



## 2019 NYSNA Legislative Action Conference Registration Awards

### **APPLICATION DEADLINE JANUARY 9, 2019**

#### **Purpose:**

NYSNA is offering awards that will include a full conference registration to attend the 2019 Legislative Action Conference in Albany, NY on January 28-29, 2019. The purpose of the award is to encourage members of NYSNA who have never attended the LAC, or who have attended in the past but are not receiving financial support from their district this year.

*The proceeds from the basket raffles at the 2018 Annual State Conference in Saratoga Springs are being used to fund as many awards as possible.*

#### **Procedure:**

The NYSNA Professional Development Committee will review the applications for the awards and select winners who will be notified by January 11, 2019. The award winners will register for conference by January 16th, by using the conference registration form and attaching the original notification letter to the registration. The award may not be transferred to another registrant nor used for any other purpose than for attending LAC 2019. The award includes all activities and meals defined on the registration form under "Full Conference".

*The award does **not** include travel or hotel registration.*

#### **Qualifications:**

1. The applicant must be a current member of NYSNA. It is acceptable for the award applicant to become a member at the time of application (to obtain a form visit the website) although preference will be given to members of longer standing.
2. The applicant must be either the decision-maker for the School Nutrition Program, or hold a position which involves purchasing for the Program.
3. Preference will be given to the applicant who has not attended the NYSNA LAC event within the last five (5) years or who has never attended the NYSNA LAC.
